Item 1. Previous Minutes

Moved HUN that the Minutes of the 2009 Annual General Meeting be approved. Seconded GBR. In Favour – 8, Opposed – 0, Abstained – 2. Carried.

There were two nominations for Access Liberty Representative. Brendan Tourelle (NZL) nominated by NZL and seconded by HUN. Herb Meyer (USA) nominated by CAN and seconded by USA. In Favour of Brendan Tourelle – 4. In Favour of Herb Meyer – 2. Abstained – 4. Brendan Tourelle (NZL) is elected as Liberty Representative.

Item 3. Rules & Measurement

a) Access 2.3, 303 & Liberty Class Rules.

Moved GBR that Liberty Class Rule and International Access 2.3 Class Rule H.4.4 be changed as follows: Sailors in a servo assist division are not permitted to manually adjust the sheets or other control lines or move the boom. To be eligible for the servo assist division, the boat must be sailed fully servo controlled, ie, only steering and sheets operated electro-mechanically. Sailors manually controlling either sheets or steering or making any adjustment to control lines, shall be deemed to be sailing the boat partial servo/manually. Seconded HUN.

Moved HUN that IACA accept the proposal from Circolo Vela Gargnano on Lake Garda, Italy to hold the 2011 Access European Championship. Seconded GBR.

h) Minimum Numbers in World & Regional Championships

Moved HUN that the IACA Championship Guidelines be amended to specify the minimum number of entries required for a division to be valid at Access Regional Championships at four (4) boats, and the minimum number of entries required for a division to be valid at World Championships at six (6) boats. For servo classes, the minimum number of entries required for a division to be valid at Access Regional Championships at three (3) boats, and the minimum number of entries required for a division to be valid at World Championships at four (4) boats. This requirement is to be clearly indicated in the Notice of Race (NOR) and other pertinent documents relating to the Regional or World Championships. Where the number of entries for any one division does not meet the minimum number by the entry closing date, that division will not be sailed in the Championship UNLESS the division can be combined with another compatible division. For example, Liberty Servo-Assist can be sailed with Liberty Open Division, or 2.3 Servo-Assist can be sailed with 2.3 Single Person Division. Where the number of Liberty or 2.3 Servo-Assist entries reaches the minimum number as per the Notice of Race by the entry closing date, medals and/or prizes will be awarded in the Servo-Assist Championship. The Servo-Assist boats will also be eligible for medals and prizes in their respective Open classes. Should either Servo-Assist division not reach the required minimum number, boats of that class would only be eligible for prizes in the Open class. Seconded by GBR. In Favour – 8. Opposed – 0. Abstained – 2. Carried.

i) The 2006 IACA Championship Guidelines are in need of updating. Action: DSt/ZP

j) Access 2.3 Divisions.

Moved GBR that separate divisions be offered for the Access 2.3S and 2.3W classes at World and Regional Championships. Should either division not meet the required minimum number of entries by the entry closing date, the classes are to be combined in one 2.3 division. Seconded USA In Favour – 3. Opposed – 4. Abstained – 3. Defeated.
